

ORDINANCE NO. 20-39

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF GRANBURY, TEXAS CANCELLING THE NOVEMBER 3, 2020 REGULAR MUNICIPAL ELECTION; ESTABLISHING POSTING REQUIREMENTS FOR THE ORDER OF CANCELLATION; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, a Regular Municipal Election was ordered by the City Council of the City of Granbury, Texas located in Hood County to be held on November 3, 2020 for the purpose of electing Councilmember, Place 4 and Councilmember, Place 6; and

WHEREAS, pursuant to Section 2.052 of the Texas Election Code, the deadline for filing applications for a place on the ballot and the deadline for filing as a write-in candidate has expired; and

WHEREAS, the City Secretary has presented a Certificate of Unopposed Candidates, attached hereto as Exhibit A, for the November 3, 2020 Regular Municipal Election to the members of the City Council.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GRANBURY, TEXAS:

SECTION 1.

That the Granbury City Council hereby cancels the election scheduled to be held on November 3, 2020, in accordance with Section 2.053(a) of the Texas Election Code. The following candidates have been certified as unopposed and are hereby elected as follows:

- Trish Reiner Councilmember, Place 4
- Greg Corrigan Councilmember, Place 6

SECTION 2.

The Mayor is hereby authorized to sign an Order of Cancellation to be in a form substantially similar to Exhibit B, attached hereto and incorporated herein for all purposes.

SECTION 3.

The City Secretary, in conjunction with the Hood County Elections Administrator, is hereby directed to post a copy of the Order of Cancellation, on Election Day at each polling place that would have been used in said election.

SECTION 4.

This ordinance shall become effective from and after its passage and approval.
